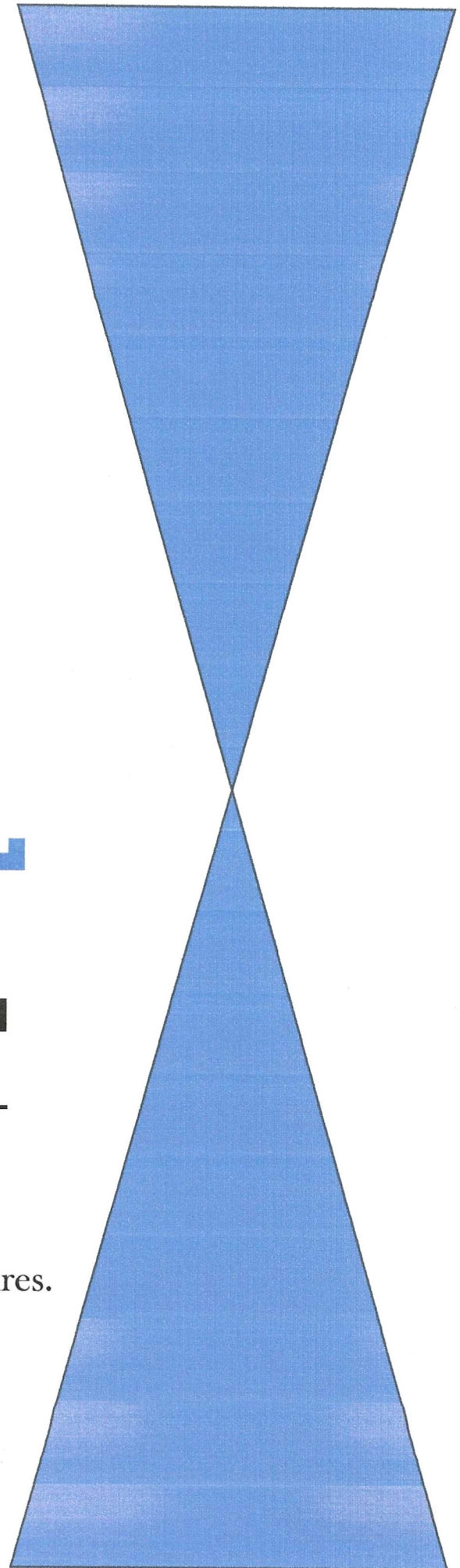

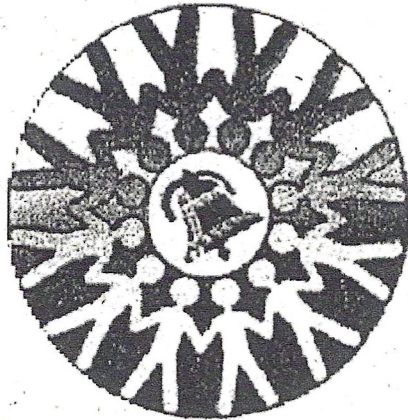

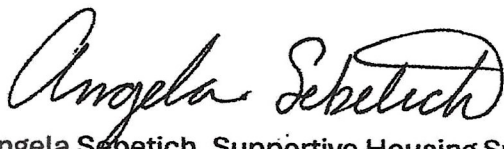

Many Hands. One Purpose. Brighter Futures.

Many hands, one purpose embodies the power of collective effort and shared goals to overcome challenges and create a brighter future, echoing the sentiment that teamwork makes heavy tasks easier. This collaborative approach brings hope, resilience, and success in challenging times, highlighting that unified action directly results in improved circumstances.

When we first started employment with the Mental Health Association of Washington County, we were so nervous. Mistakes were made and lots of mistakes have happened. We have more questions than answers some days. We have been assured that everything is fixable. Every question we had no matter how simple or complex it was; we never felt like it was a bother to any of our teammates. No questions were too small or too big. Everyone in our office has a team approach to help us learn and understand our job duties. All the praises have helped build confidence that is needed to strive and not become frustrated with all the tasks and challenges of daily work assignments. With all the help and understanding, we learned to pass this positive approach to our consumers while assisting them to learn how to budget their benefits and most importantly need vs wants. When anyone of us in our office has an issue or concern everyone comes together to help develop an action plan for a brighter outcome. Some days it feels like a puzzle, each of us is a piece and together we become a whole puzzle.

The Representative Payee program is designated for a consumer with a Mental Health diagnosis who is recipient of any type of Social Security Benefits, who also experiences difficulties with budgeting and require assistance in managing their finances. It takes many hands with the Representative Payee program to assist 160 consumers with their financial day to day needs. We have one purpose, one goal to assist our consumers to become financially sound and enhance their quality of life for a brighter future.

Many Hands. One Purpose. Brighter Future.

Dating back to the 1300s people acknowledged that using many hands makes for lighter work, sharing a burden simplifies difficult tasks. Working as a team towards one purpose is essential for successfully achieving one goal. Resilience serves as a reminder to maintain hope during difficult times. Having a collective action plan and perseverance means hard work and unity creates a positive brighter future, even when facing adversity, leading to brighter future.

A Consumer/Family Satisfaction Team(C/FST) is a group of people with lived experience who confidentially survey Community Care Behavioral Health members of Mental Health and Substance Use Disorder services in Greene County. This is done to ensure quality, identify gaps, and improve care, operating as a key part of public behavioral health systems in Pennsylvania. CFST monitors conduct surveys, handle complaints and provide feedback to providers. C/FST Monitors empower Consumers/Family Members to voice needs and ensure services are responsive and effective. Consumer and Family Satisfaction Team members are, or have been, consumers of mental health and/or substance use disorder services. They could also be in Recovery. Members could be family members, and family members of children and adolescents with serious emotional disturbance and/or substance use disorders.

It takes many hands working with our Consumer Family Satisfaction Team to be beneficial and successful for the consumers we serve. During our day-to-day, we have had the opportunity to meet different people, observe different environments and listen to all kinds of situations that consumers have had to face during their life. Some situations are very familiar to our own struggles. By offering the C/FST survey it gives the consumers a voice to be heard. It gives them a chance to voice their opinions without judgement in a confidential environment. Most consumers state they are happy to have someone that is willing to listen to their concerns, likes and/or dislikes of the services they receive. We have one purpose to strive to improve the quality of care. We give a listening ear, share their voice anonymously and provide resources to those who may/may not be struggling. This can all help consumers have a brighter future that is promising, successful and a happy time ahead filled with opportunities, growth and optimism.

It's a wonderful feeling when a consumer walks out of the room with a smile on their face, at that moment you know you have given someone an opportunity for a brighter day.
